6.3.7	G	A firm should ensure that the systems and controls include:
		(1) appropriate training for its employees in relation to <i>money laundering</i> ;
		(2) appropriate provision of information to its <i>governing body</i> and senior management, including a report at least annually by that <i>firm's money laundering reporting officer</i> ( <i>MLRO</i> ) on the operation and effectiveness of those systems and controls;
		<ul> <li>(3) appropriate documentation of its risk management policies and risk profile in relation to <i>money laundering</i>, including documentation of its application of those policies (see SYSC 9);</li> </ul>
		(4) appropriate measures to ensure that money laundering risk is taken into account in its day-to-day operation, including in relation to:
		(a) the development of new products;
		(b) the taking-on of new customers; and
		(c) changes in its business profile; and
		(5) appropriate measures to ensure that procedures for identification of new customers do not unreasonably deny access to its services to potential customers who cannot reasonably be expected to produce detailed evidence of identity.
6.3.8	R	(1) A <i>firm</i> must allocate to a <i>director</i> or <i>senior manager</i> (who may also be the <i>money laundering reporting officer</i> ) overall responsibility within the <i>firm</i> for the establishment and maintenance of effective anti- <i>money laundering</i> systems and controls.
		(2) A <i>firm</i> may not allocate overall responsibility under (1) to a <i>person</i> who is approved to perform the <i>other overall responsibility function</i> .
		The money laundering reporting officer
6.3.9	R	A firm (with the exception of a sole trader who has no employees) must:
		(1) appoint an individual as <i>MLRO</i> , with responsibility for oversight of its compliance with the <i>FCA</i> 's <i>rules</i> on systems and controls against <i>money laundering</i> ; and
		(2) ensure that its <i>MLRO</i> has a level of authority and independence within the <i>firm</i> and access to resources and information sufficient to enable him to carry out that responsibility.
6.3.10	G	The job of the <i>MLRO</i> within a <i>firm</i> is to act as the focal point for all activity within the <i>firm</i> relating to anti- <i>money laundering</i> . The <i>FCA</i> expects that a <i>firm</i> 's <i>MLRO</i> will be based in the United Kingdom.
