**1.1A.1** **R** *APER* applies to *FCA-approved persons* who are approved to perform a *controlled function* in **■ SUP 10A** (FCA Approved Persons in Appointed Representatives).

**What?**

- 1.1A.2** **P**
- (1) *APER* applies to the performance by an *approved person* of *FCA controlled functions* in **■ SUP 10A** (FCA Approved Persons in Appointed Representatives) (whether or not approval has been sought and granted).
  - (2) *APER* also applies to the performance by an *approved person* of any other functions in relation to the carrying on of a *regulated activity* by their *authorised approved person employer*.
  - (3) Subject to (4), *APER* does not apply to conduct to which *COCON* applies.
  - (4) *APER* applies to conduct to which *COCON* does not apply under **■ COCON 1.1.8AR** (To what conduct does it apply?).
  - (5) *APER* does not apply to conduct unless it is within the scope of section 64A of the Act (Rules of conduct).

- 1.2.2 G The *guidance* in ■ APER 3 and ■ APER 4 is *guidance* on the *Statements of Principle* and is called the *Code of Practice for Approved Persons*.
  
- 1.2.3 G The *Code of Practice for Approved Persons* sets out descriptions of conduct which, in the opinion of the *FCA*, do or do not comply with a *Statement of Principle*. The *Code of Practice for Approved Persons* also sets out, in certain cases, factors which, in the opinion of the *FCA*, are to be taken into account in determining whether or not an *approved person's* conduct complies with a *Statement of Principle*.

- 1.2.5 G As set out in ■ SUP 10A.3.1 R (Provisions related to the *Act*), a function is a *controlled function* only to the extent that it is performed under an *arrangement* entered into by:
  - (1) a *firm*; or
  - (2) a contractor of the *firm*;

in relation to the carrying on by the *firm* of a *regulated activity*.
