## Warning and decision notices

		6.1 Application and purpose
		Application
6.1.1	G	This chapter contains guidance for <i>issuers</i> and <i>owners</i> and other persons subject to the <i>RCB Regulations</i> .
		Purpose
6.1.2	G	The purpose of this chapter is to set out the FCA's statement of the procedure which it proposes to follow on giving <i>warning notices</i> and <i>decision notices</i> in relation to <i>regulated covered bonds</i> .

		6.2 Policy on decision and warning notices
6.2.1	G	<b>Decision and warning notices</b> When making a decision on an application for registration under the <i>RCB</i> <i>Regulations</i> , or in relation to material changes to the contractual terms of the <i>regulated covered bond</i> , or in relation to a change of <i>owner</i> , or when seeking to use direction, revocation or penalty powers, the <i>RCB Regulations</i> require the <i>FCA</i> to give the subject of the intended action a <i>warning notice</i> and a <i>decision notice</i> . The recipient of a <i>warning notice</i> has the right to make representations to the decision maker, and may refer the decision to give a <i>decision notice</i> to the <i>Tribunal</i> .
6.2.2	G	Regulation 44 of the <i>RCB Regulations</i> (Warning notices and decision notices) applies Part XXVI of the <i>Act</i> (Notices) in respect of notices that we give under the <i>RCB Regulations</i> . This means that the provisions of section 393 of the <i>Act</i> (Third party rights) and section 394 of the <i>Act</i> (Access to Authority material) apply to penalty procedures under the <i>RCB Regulations</i> and that, if the matter is not referred to the <i>Tribunal</i> , then upon taking the action to which a <i>decision notice</i> relates, the <i>FCA</i> will issue the subject of the decision notice a <i>final notice</i> . The <i>FCA</i> is required to publish such details about the matter to which a <i>final notice</i> relates as it considers appropriate.
6.2.3	G	<ul> <li>FCA decision maker</li> <li>DEPP 2 Annex 1 G identifies the relevant decision maker in relation to warning notices and decision notices issued by the FCA under the RCB Regulations.</li> </ul>
6.2.4	G	Decisions on applications for registration, in relation to material changes to contractual terms of the <i>regulated covered bond</i> , or in relation to a change of owner, or decisions to issue a direction under the <i>RCB Regulations</i> or to revoke an <i>issuer</i> 's registration, will be taken under <i>executive procedures</i> following the process set out in DEPP 4.
6.2.5	G	Decisions to impose a financial penalty under regulation 34 of the <i>RCB</i> <i>Regulations</i> will be taken by the <i>RDC</i> under the procedure set out in DEPP 3.2 or, where relevant, DEPP 3.3.
